**CERTIFICATE OF REGISTRATION AS
PENSION FUND MANAGER**

The Securities and Exchange Commission of Pakistan, having considered the application for registration of 786 Investments Limited and being satisfied that 786 Investments Limited is eligible for registration, in exercise of powers conferred by sub-rule (2) of rule 5 of Voluntary Pension System Rules, 2005 (the "VPS Rules"), hereby grants registration to 786 Investments Limited as Pension Fund Manager subject to the conditions stated herein below or as may be prescribed or imposed hereafter:

- (i) 786 Investments Limited shall strictly comply with part VIII-A of the Companies Ordinance, 1984, the Companies Act, 2017, the VPS Rules, the Non-Banking Finance Companies and Notified Entities Regulations, 2008, Non-Banking Finance Companies (Establishment and Regulation) Rules, 2003, guidelines and directives issued from time to time under the VPS Rules and any other law applicable in this regard; and
- (ii) 786 Investments Limited shall not make any offer to any person/public to participate in any of its pension fund(s)/scheme(s) unless the Commission has authorized such fund(s)/scheme(s) under the VPS Rules.
- (iii) The company shall strictly comply with the requirements prescribed under Rule 9 of the Voluntary Pension System Rules, 2005. Authorization to manage an employer pension fund shall be granted only upon the company attaining an AM2 rating in accordance with Rule 9 of the said Rules.

The registration shall be suspended or cancelled if the License to carry on Asset Management Services granted to 786 Investments Limited under Non-Banking Finance Companies (Establishment and Regulation) Rules, 2003 is suspended/cancelled or revoked.
